X _____ **All dogs must have current vaccinations against Rabies, Distemper and Bordetella (Kennel Cough)** We will need proof of vaccinations prior to the first day of daycare. Puppies can begin daycare after they have received their Bordetella and 2nd Distemper vaccinations; we will need proof of Rabies and 3rd Distemper shots once received.

X _____ **All dogs over the age of 1 year must be spayed/neutered.** Even though our daycare room is always monitored, in order to create a safe play environment we no longer accept dogs over the age of 1 year that are not spayed/neutered.

X _____ **All dogs are required to have flea protection throughout the year.** Any dog that has fleas will not be allowed in daycare until resolved.

X _____ **All dogs must wear a collar and must be on leash when entering and leaving the building.** You must provide a collar for your dog to wear during their stay in daycare & boarding.

X _____ **Written or verbal permission is required if you wish to have someone else pick up your dog.** Please notify staff prior to pick up time.

X _____ **A \$20 late fee will be charged for any dog picked up after closing.** If you know you will be late, please call to let us know so we can plan accordingly.

Our mission is to provide a safe and playful environment for your dog to help him/her socialize with others and go home happy and tired from a long day of fun. Our play areas are always staffed and closely monitored for any signs of health concerns, behavioral changes or negative interactions with other dogs. We ask that you understand that this is an active environment with other animals, and that dogs can sustain small nicks or cuts while playing with other dogs. Our staff will be sure to notify you immediately with any concerns that arise during his/her stay. We appreciate any questions/concerns/requests that you may have for us.

Hold Harmless Agreement

By signing this form, you acknowledge, accept, and understand the terms and conditions set forth in this agreement.

By signing this document, you also agree not to hold Paws Puppy Palace LLC, its' owners, employees, or any other representative liable for any injuries or death to your dog while in the care of Paws Puppy Palace LLC.

I understand that Paws Puppy Palace LLC in admitting my dog has relied on my representation of my dog to determine that my dog is in good health, has not shown aggression, and has not harmed or exhibited threatening behavior toward any person or another dog.

I understand that by bringing my dog to Paws Puppy Palace LLC I am granting permission for my dog to socialize and intermingle with other dogs.

I acknowledge that Paws Puppy Palace LLC is an open play environment and there are inherent risks which can occur even when monitored, and that injuries to dogs, owners or my guests might be reasonably foreseen to result from off leash play and socialization in the facility. I agree to accept responsibility for myself, my dog, and my representatives and will hold harmless Paws Puppy Palace LLC, its' owners, employees, or any other representative for any injury or illness that may result from my use of the facility and its' services. I also acknowledge that transfer of communicable illnesses such as but not limited to kennel cough, viruses or parasites and/or injuries can occur. Most are benign such as broken toenails, sore pads, abrasions, cuts or punctures particularly on shorter haired breeds of dogs. On behalf of myself, my dog, and my representatives I hold harmless Paws Puppy Palace LLC for any costs, damages, claims or expenses that may incur from our use of the facility.

I understand that any behavior deemed dangerous or inappropriate may result in dismissal from daycare and if such behavior occurs Paws Puppy Palace LLC will treat the behavior at their discretion and that I am solely responsible for any harm or damage that my dog causes.
